BOS LIAISON REPORT - Diana Yeisley, currently at a Town Budget meeting, reported by email. Board of Selectman recognized and read a proclamation declaring **April as autism awareness month**. A young man, Will Braunlich, who is on the autism spectrum, spoke. There were several young adults with autism in attendance, and this had support from the entire board.

Part of the budget process includes looking at some town positions, one of which was funded with ARPA funds, which have come to an end; unfortunately, the position held by Erika Cleveland was eliminated from social services. The **budget referendum** is tentatively set for May 16.

Simsbury Community Cleanup Day is this Saturday, April 20, from 9 to 11. Supplies will be available at Town Hall. Registration is not required.

Hazardous Waste Collection will be Saturday, April 20, from 8 to 1 at Farmington High School. This is free to Simsbury residents.
